As this funding comes to an end, districts have been fiscally responsible and planned for the ESSER fiscal cliff by having reserved some of their other federal funds to help assure the best practices put into place can continue into the future. LEAs and the SEA have also been faced with challenges due to staff shortages in various positions during the 2023-24 school year and are working to find ways to improve in this area. Nebraska is requesting waivers consistent with the requirements of ESEA section 8701(b)(1)(C) and (F). These waivers will provide the eligible LEAs and the SEA the opportunities needed to assure the best use of funds, to support the evaluation of the practices in place, and to monitor the processes for future success.
